1. Executive Summary

Considered one of the fastest-growing economies in Africa, Egypt figures amongst the five-largest economies of the African continent. Egypt's fundamental role in contributing to the African continent's growth is evidenced by the fact that the country accounted for the highest, i.e. about one-third of the aggregate growth rate, of 3.4% estimated for Africa for 2019 by the African Development Bank (AfDB) in its *African Economic Outlook 2020 (AEO)* report.

Until the early 1990s, under the rule of President Gamal Abdel Nasser, Egypt was a highly-centralized economy focussed mainly on import substitution. However, in the early 1990s, the country embarked upon an ambitious economic reform programme to improve its macroeconomic performance and address structural issues through the liberalization of the exchange rate, fiscal consolidation, and energy sector reforms. These measures have helped stimulate economic growth, generate budgetary surplus, reduce the debt-to-GDP ratio and replenish foreign reserves.

Since 2000, the pace of structural reforms — including fiscal, monetary policies, taxation, privatisation and new business legislations — have helped Egypt move towards a more market-oriented economy and resulted in increased foreign investment. A new Investment Law was issued on 31 May 2017, abolishing the current law and introducing new incentives for investors. The new investment law includes notable amendments such as establishing private free zones which were previously abolished in the earlier investment regime. The new law also focusses on simplifying the incorporation process with all corporate procedures managed electronically.

According to the World Bank, the country's GDP growth was 5.3% in 2018, compared to 4.1% and 4.3% in the previous two years. This robust performance was sustained throughout the first half of fiscal year 2020, driven mainly by investments and the improving balance of net exports. The government has changed its trade policy from import substitution to export promotion in order to increase the volume of trade between Egypt and other countries and decrease the current account deficit.

In response to the COVID-19 situation, on 14th March 2020, the Government of Egypt announced a US\$ 6.4 billion stimulus package to mitigate the impact of the pandemic on the country's economy. This stimulus package comprises the following measures:

- ☐ Reduction of natural gas and electricity prices for industries
- ☐ Postponement of repayment of loans for small- and medium-sized companies by six months and the cancellation of ATM withdrawal fees for the same period
- ☐ The country's central bank, the Central Bank of Egypt (CBE), has allocated 20 billion Egyptian pounds (US\$ 1.2 billion) to support the country's stock exchange
- ☐ Increase of the daily withdrawal limits for credit and debit cards by the central bank
- ☐ Grant of an 'immediate' financing for the import of key commodities

Further, the CBE announced a rate cut of 3% that has brought down the credit and discount rate from 12.75% to 9.75%. In addition, economic stimulus measures have been announced to

insulate the Egyptian economy from the adverse impact of COVID-19 to the extent possible. Some of these include the following:

- ☐ Extension of grace period of three months for the payment of real estate tax due on industrial and tourism entities
- Allowing six-month installments for due real estate tax on industrial and tourism entities
- ☐ Extension in suspension of the agriculture holding tax for two more years

With an estimated population of ~100 million in 2019, Egypt is the third-most populous nation in the African continent. About 95% of the country's population resides along the banks of the Nile, in the Nile Delta and along the Suez Canal, thus making these areas one of the world's most densely populated regions with over 1,540 persons per square km. Urbanisation levels in Egypt are not as high in other developing nations, with less than 50% of the country's population residing in urban areas, thus offering increased scope for urbanisation-related economic and business activity. Egypt has a relatively young population with 52% of its population in the age group of 20–64 years in 2019; the population in the age bracket of 65 years and more accounted for 8% of the aggregate population in 2019. The increasing working age population implies growing demand for new skills/skills upgradation.

In the World Bank's *Doing Business 2020* report, Egypt ranked 114th amongst the 190 countries on the *Ease of Doing Business* rankings, moving up by six places compared to the previous year's rankings. This improvement in ranking is owing to the Egyptian government's implementation of several reforms to improve the investment climate and simplification of procedures in various areas, including establishment of companies, protection of minority investors, providing electricity connections, etc.

Given this strategic context, CII has prepared this detailed report on Egypt's import profile providing in-depth insights into Egypt's import basket. In addition to covering Egypt's socio-economic fundamentals briefly, the report deep dives into Egypt's import profile comprising of a detailed analysis resulting in shortlist of products that hold potential for Indian business to export to the country.

This report comes at a time when the world is passing through a challenging period due to the spread of COVID-19. With investment activity being completely stalled at the moment and demand for FDI significantly impacted given the global moratorium on travel, this immediately calls for scouting for export opportunities for Indian businesses. Moreover, the COVID-19 outbreak has resulted in supply disruptions particularly from China. According to the UNCTAD report on *Global Trade Impact of COVID-19 Epidemic*, about 20% of global trade in manufacturing intermediate products originated in China (up from 4% in 2002), thus making it the main supplier of intermediate inputs for manufacturing companies abroad. This reduction in Chinese imports of commodities offers opportunities for Indian exporters to step up and fill in the gaps created by disruption in China's exports.



2. Top Imports, CAGR and Countries

International trade has had a limited role in driving Egypt's economic growth, with trade accounting for only 48.3% of the country's GDP in 2018, according to the World Bank. This limited part played by foreign trade in shaping Egypt's growth story is attributed largely to the country's historically inward-looking foreign trade policies focused mainly on import substitution and on building local manufacturing capabilities. According to the World Bank, in 2018, Egypt's imports of goods and services as a percentage of GDP was 29%, whereas the exports of goods and services as a percentage of GDP was 19%, thus pointing to the constrained openness of the economy to international trade.

The primary objective of this report is to perform a thorough analysis of the country's import basket with the aim of highlighting the country's export potential for Indian industry. As a starting point for this analysis, the table below provides a list of the top 25 products imported by Egypt over the period 2014–18 and the imports' compound annual growth rate (CAGR).

The country's imports basket is dominated by food and agri products, electronics, energy, pharmaceuticals, plastics, iron, copper, fabrics, and machinery and equipment. However, several categories have exhibited either negative, slowing or tepid growth in the rate of imports over the period 2014 to 2018, indicating a lethargy in its economy, which has been struggling to achieve



GDP growth rates achieved during 2006–08. Imports with significant growth include motor vehicles, fabrics, coal and iron ore, and some categories in the electronics sector.

The analysis below provides a list of top exporters for each of the top 25 products so as to provide a comprehensive overview of Egypt's import profile. The analysis below also examines India's exports of these products to Egypt (if any) and the tariffs levied by Egypt. It is hoped that the analysis below can highlight some instances where Indian industry can increase its share in Egypt's imports' basket by undertaking focussed exports projects.

Maize is the second-most important cereal crop in Egypt and nearly 50% of its production is used as livestock and poultry feed. Given its wide usage, there is a gap between production and consumption of maize in Egypt, which is estimated at around 45%; this gap is compensated by imports, which is reflected in maize being a top import item for the country, albeit with an imports' CAGR of -1% for 2014–18. India does not feature as a source country for maize for Egypt, though it is ranked no. 20 globally on the export of maize in 2019, with exports worth US\$ 105 million. In fact, India is the sixth-largest maize producing country in the world, with production of 26 million metric tonnes per year. There is, therefore, a market for the maize industry to explore in Egypt in spite of the slightly-negative imports' CAGR registered during the period under consideration. With a steady imports' CAGR of 4%, HS Code 300490 is an important sector for Indian industry given its strengths in this category and acknowledged global standing. However, India's ranking as a source country of this product category for Egypt is low at 22, compared to its global ranking of 10 with exports worth US\$ 10,742 million in 2018. A major reason for this is possibly the lack of an FTA or preferential tariff agreement with Egypt. The average MFN tariff levied is 3.3%, while the preferential tariffs levied are 0% (Arab-Mediterranean countries, EFTA countries, Turkey, COMESA and EU countries), 3% (Ethiopia under COMESA), 0.67% (Uganda and Eritrea under COMESA) and 2.5% (MERCOSUR countries). There is, therefore, potential for increasing exports of India-made medicaments to Egypt if a preferential tariff can be agreed upon. See list of Egyptian importers of HS Code 300490 in Annexure 2.

This product category appears to be heavily-prohibitive with a negative imports' CAGR of -5% for 2014–18 and an average MFN tariff at 90%. India's exports of HS Code 870323 to Egypt have shown large swings during the period under consideration, from US\$ 5.9 million in 2014 to US\$ 27 million in 2015 and US\$ 70 million in 2016, before plunging again in the following year to the current rank and volumes. The high tariff rate is definitely a deterrent in increasing exports from India, given that Egypt's preferential tariff partners are levied much lower rates of 0% (Arab-Mediterranean countries, COMESA and EU countries), 9% (EFTA countries and Turkey), 18% (Uganda and Eritrea under COMESA) and 81% (Ethiopia under COMESA). Globally, India ranked 23 in 2018, with exports worth US\$ 1,939 in that year. See list of Egyptian importers of HS Code 870323 in Annexure 3.

Though Egypt has a steady import demand for HS Code 271113 with an imports' CAGR of 6% for 2014–18, there is no potential for India's exports of this product category as India is a net importer of liquified butane. Moreover, for its trade partners, the tariff levied is lower than the average MFN tariff of 5.0%, with rates of rates of 0% (Arab-Mediterranean countries, EU countries, EFTA countries, COMESA and Turkey), 1% (Uganda and Eritrea under COMESA), 4.5% (Ethiopia under COMESA) and 2.5% (MERCOSUR countries). An important export category under the animal products sector, HS Code 020230 has exhibited de-growth with a negative imports' CAGR of -1% for 2014–18. India is recognised as a major exporter globally of this product category and this is reflected in its second rank as a source country of frozen, boneless meat products to Egypt. So, while the import demand is in the negative territory, there is a significant difference between India and the top-ranking country, Brazil. There is, therefore, ample scope for industry players in this segment to bridge this gap and garner a larger share of Egypt's imports of this product category. Moreover, though India ranks no. 2 as a source country for Egypt for HS Code 020230, India's exports to Egypt have been steadily falling during the period under consideration, from US\$ 530 million in 2014 to US\$ 405 million in 2015 to US\$ 376 million in 2016 to US\$ 322 million in 2017 and finally down to US\$ 112 million in 2018. This declining trend only reiterates the need to increase focus on expanding exports in this category to regain export volumes achieved earlier. Globally, India is ranked high at no. 3 with exports worth US\$ 3,076 million in 2019. See list of Egyptian importers of HS Code 020230 in Annexure 5.

Egypt exhibited a very strong imports' CAGR of 26% during the period 2014 to 2018 for HS Code 851712. India is currently ranked no. 3 and there is a strong impetus to increase exports of this product category to Egypt. However, India's exports of HS Code 851712 have had a chequered journey during the period under consideration; Indian exports were worth US\$ 62 million in 2014, then fell drastically to US\$ 5 million in 2015, nil exports were registered in 2016 which revived slightly to US\$ 9,44,000 in 2017, and then a much stronger revival in 2018 to clock US\$ 11.4 million. With a global rank of 16, with exports worth US\$ 1,065 million in 2018, primarily to the UAE (US\$ 690 million in 2018), Russia (US\$ 141 million in 2018) and South Africa (US\$ 73 million in 2018), there appears to be capacity for Indian industry to increase exports of HS Code 851712 to Egypt. Despite having a strong imports' CAGR of 16% for 2014–18, HS Code 260112 is not an attractive category for India given nil exports to Egypt for most part during the period under consideration; India exported US\$ 8.2 million in 2014 and this was followed by nil exports in the remaining years. However, India is ranked fairly well at no. 7 globally on the exports of HS Code 260112, with exports worth US\$ 1,262 million in 2019 to China (US\$ 913 million), Oman (US\$ 97 million), Korea (US\$ 73 million), Turkey (US\$ 53 million) and Malaysia (US\$ 38 million). Therefore, further analysis should be undertaken to ascertain weak, or nil, exports of HS Code 260112 to Egypt and for Indian industry to undertake focussed export projects for this product category to Egypt. There appears to be little scope for increasing India's exports of HS Code 720449 given nil exports for most of the years during the period under consideration and the given the imports' CAGR of 0% for 2014–18; India recorded minuscule exports worth US\$ 0.8 million of this product category to Egypt in 2017. Therefore, HS Code 7201449 is not an attractive product category for exports to Egypt. Globally, too, India is ranked abysmally low at 97 on exports of HS Code 720449. One reason for this could be the substantial market for this product category domestically, which renders exports redundant. See list of Egyptian importers of HS Code 720449 in Annexure 8.

A product category with middling exports prospects for India given the decline in exports over 2017 and 2018, which is offset by the high imports' CAGR of 23% for 2014–18. India's exports of HS Code 870322 to Egypt went from US\$ 35 million in 2014 to US\$ 92 million in 2015, plummeting to US\$ 25 million in 2016 and further to US\$ 1.8 million in 2017 and US\$ 3.4 million in 2018. Therefore, in spite of a high average MFN tariff of 26.0% on exports from India, the export values achieved during 2014 to 2016 were significant. For free-trade partners, the preferential tariffs levied are 0% (Arab-Mediterranean countries, EU countries and COMESA), 2.4% (EFTA countries and Turkey), 23.4% (Ethiopia under COMESA), 5.2% (Uganda and Eritrea under COMESA) and 21.2% (MERCOSUR countries). With a heavily-negative imports' CAGR of -18% for 2014–18, HS Code 271019 (diesel, light diesel oil, fuel oil and bunker oil) is not an attractive product category for exports. During the period under consideration, India's exports of HS Code 271019 to Egypt touched a high of US\$ 22.5 million in 2014, and have shown a declining trend since then. This is one product category, though, in which India is a top exporting country, with a global rank of no. 5 and exports worth US\$ 32,004 million in 2018. However, even if India attempts to ramp up exports to Egypt, its exports will be hampered by the preferential tariff levied on exports from free-trade partner countries, which are at 0% (Arab-Mediterranean countries, EU countries, Turkey, COMESA and EFTA countries), 4.5% (Ethiopia under COMESA), 1% (Uganda and Eritrea under COMESA) and 2.5% (MERCOSUR countries). This is another product category where Egypt's free-trade partners enjoy a preferential tariff regime, which is levied at the rate of 0% (Arab-Mediterranean countries, EU countries, Turkey, COMESA and EFTA countries), 1.8% (Ethiopia under COMESA), 0.4% (Uganda and Eritrea under COMESA) and 1.6% (MERCOSUR countries). Moreover, the product category has a tepid 2% imports' CAGR for 2014–18. India does not feature as a source country for HS Code 740311 for most years in the period under consideration, with exports worth US\$ 15.7 million in 2014, falling to US\$ 2.7 million and US\$ 3.6 million in 2015 and 2016, respectively; nil exports were registered in 2017 and 2018. India's exports of HS Code 852990 to Egypt have see-sawed during the period under consideration, from US\$ 0.2 million in 2014 to US\$ 14,000 in 2017, followed by a slight uptick to US\$ 0.7 million in 2018. So, while India ranked no. 10 in 2018 as a source country for HS Code 852990, the volume of exports is minuscule and appears to have limited opportunities for growth. Moreover, with a negative imports' CAGR of -5% for 2014–18 and levy of an average MFN tariff of 1.6%, there appears to be little potential or scope for Indian industry to increase exports of this product category to Egypt. The preferential tariffs extended by Egypt to its free-trade partners for this product category are 0% (Arab-Mediterranean countries, EU countries, Turkey, COMESA and EFTA countries), 1.44% (Ethiopia under COMESA), 0.32% (Uganda and Eritrea under COMESA) and 1.05% (MERCOSUR countries). Though India is a strong exporter globally of HS Code 390210, it has insignificant exports of the product category to Egypt; in the period under consideration, exports have hovered around US\$ 0.4 million, only increasing to US\$ 2.2 million in 2017. Moreover, with an imports' CAGR of 0% for 2014–18 and an average MFN tariff of 2.5%, there is very limited scope for India to increase its exports of this product category to Egypt. The preferential tariffs extended by Egypt to its free-trade partners for this product category are 0% (Arab-Mediterranean countries, EU countries, Turkey, COMESA, MERCOSUR and EFTA countries), 2.25% (Ethiopia under COMESA) and 0.5% (Uganda and Eritrea under COMESA). This product category offers scope for India to increase exports given the imports' CAGR of 3% for 2014–18 and India ranking of 11 as a source country. India's exports of HS Code 390110 to Egypt during the period under consideration have conveyed signs of growth, rising from US\$ 1.8 million in 2014 to US\$ 3 million in 2016 and US\$ 2.9 million in 2018. Given that this is one of the few product categories that does not have a preferential tariff regime, Indian industry could explore projects to increase its share of this product's imports by Egypt. Globally, India is ranked 13 with exports worth US\$ 539 million in 2019. In spite of a preferential tariff regime, India is ranked 11 as a source country for HS Code 848180, which indicates potential, especially in view of the imports' CAGR of 6% for 2014–18. India's exports of this product to Egypt have shown significant swings, rising from US\$ 1.6 million in 2014 to US\$ 3.1 million in 2015, falling back to US\$ 1.6 million in 2016, then rising sharply to US\$ 8.3 million in 2017 and then declining again to US\$ 4.5 million in 2018. Globally, India is ranked 14 as an exporter of HS Code 848180, with exports worth US\$ 867 million in 2019; in fact, India's global exports of this product category have shown a steady increase during the period 2015 to 2019, from US\$ 700 million in 2015 to US\$ 707 million in 2016 to US\$ 769 million in 2017 to US\$ 776 million in 2018 and to US\$ 867 million in 2019. Therefore, there appears to be potential for increasing exports of this product category. A negative imports' CAGR of -4% for 2014–18 is a deterrent for expanding exports of this product category to Egypt; however, given the prevalence of preferential tariffs for free-trade partner countries and India's ranking as the fifth-largest source country nonetheless implies that Indian firms should explore the possibility of garnering a larger share of this product's imports. Exports by India of HS Code 401120 were at a peak in 2014 at US\$ 16.5 million, falling to US\$ 5.8 million, US\$ 7 million and US\$ 7.7 million in 2015, 2016 and 2017, respectively. In 2018, exports revived to touch US\$ 11.1 million. With a substantial negative imports' CAGR of -17% for 2014–18, this product category is not attractive for exports to Egypt. Moreover, India's exports of HS Code 851762 to Egypt during the period under consideration have been inconsequential, indicating the lack of potential for Indian companies to increase exports of this product category to Egypt. Globally, while India is ranked an equally-low at 28, there is a silver lining in that exports to global markets have shown a steady growth over the period 2015 to 2018, with exports rising steadily from US\$ 168 million (2015), US\$ 182 million (2016), US\$ 423 million (2017) and US\$ 627 million (2018). Though Egypt had a heavily-negative imports' CAGR of -11% for the period 2014–18 and has a preferential tariff regime that favours its free-trade partner countries, India is still ranked as the third-largest source country for HS Code 870899. Therefore, Indian industry should look at maintaining export volumes achieved during the period under consideration and explore further growth opportunities if and when import demand for this product category reverses its negative



trend. India's exports of HS Code 870899 to Egypt during 2014 to 2018 have been fairly steady at US\$ 32.7 million in 2014, US\$ 36.5 million in 2015, US\$ 32.5 million in 2016, US\$ 29.2 million in 2017 and US\$ 34.1 million in 2018. Globally, too, India is ranked high at 10 with exports worth US\$ 2,663 million in 2019. The difference in exports values of the top five sourcing countries is negligible; this affords Indian firms an opportunity to garner a larger share of this product's imports in case global supply chains are impacted because of the current challenges. The preferential tariffs extended by Egypt to its free-trade partners for this product category are 0% (Arab-Mediterranean countries, EU countries, COMESA, EFTA countries and Turkey), 8.2% (Ethiopia under COMESA), 1.82% (Uganda and Eritrea under COMESA) and 6.67% (MERCOSUR countries). In the food and agri sector, this product category offers immense scope for India to increase exports given the soaring imports' CAGR of 30% for 2014–18 and India's current ranking as the second-largest source country. India's exports of HS Code 100630 to Egypt during the period under consideration have been substantial at US\$ 17.2 million in 2014, US\$ 21.8 million in 2015, US\$ 31.9 million in 2016, US\$ 44.2 million in 2017 and US\$ 26 million in 2018. Though this product category exhibited a steady imports' CAGR of 6% for 2014–18, India does not figure as a source country for Egypt for HS Code 950300. Moreover, an average MFN tariff rate of 20% renders imports from India unviable when compared to imports from free-trade partner countries. The preferential tariffs extended by Egypt to its free-trade partners for this product category are 0% (Arab-Mediterranean countries, EU countries, COMESA, EFTA countries and Turkey), 18.0% (Ethiopia under COMESA), 4.0% (Uganda and Eritrea under COMESA) and 13.75% (MERCOSUR countries). This is one product category that appears to offer significant potential for Indian companies owing to a very strong imports' CAGR of 26% for 2014–18, India's ranking as the third-largest source country and levy of an average MFN tariff of 0%. In fact, India's exports of HS Code 854470 to Egypt have exhibited steady growth during the period under consideration, from US\$ 34,000 in 2014 to US\$ 0.1 million in 2015, US\$ 0.3 million in 2016, US\$ 0.8 million in 2017 and US\$ 1.9 million in 2018. There is a significant gap between India and the top-ranking source country and efforts to bridge this gap through focussed export projects could be undertaken.

From the table above, it appears that China is the only source country for HS Code 600192 for Egypt, in spite of the prevalence of a preferential tariff regime for its free-trade partner countries. The preferential tariffs extended by Egypt to its free-trade partners for this product category are 0% (Arab-Mediterranean countries, EU countries, COMESA, EFTA countries and Turkey), 9.0% (Ethiopia under COMESA), 2.0% (Uganda and Eritrea under COMESA) and 7.5% (MERCOSUR countries). India is not a source country of this product category and is, in fact, a net importer of HS Code 600192. Therefore, in spite of a very strong imports' CAGR of 23% for 2014–18, there is no potential for Indian industry to undertake exports in this category. 3. Balance of Trade, Product-Wise

Analysing the balance of trade (BoT) indicates the attractiveness of a market from the perspective of participation in trade fairs. For the purposes of this report, the BoT is calculated at the product level, rather than for the country per se; such an analysis indicates if a particular product is being imported for domestic consumption, or whether it is being imported to enable re-exports after either value-addition or to take advantage of FTAs.

Typically, a market with a negative BoT is one where the product is consumed domestically and, hence, Indian companies should attend B2C trade fairs in Egypt for these products; on the other hand, attendance in B2B trade fairs is recommended for products wherein Egypt has a positive BoT. The BoT for the top 25 products imported by Egypt is as follows:

If products with a positive BoT are excluded, of the top 25 products imported by Egypt, there are 24 products that exhibit a negative BoT and, hence, are target for exports by Indian businesses. The table below highlights the product categories that are either already top export items for India, or, those that have the potential for exports going forward, taking into account imports' CAGR, India's rank as a source country for Egypt, India's ranking globally and potential thereof. In some instances, there is potential in spite of a de-growth in import demand from the perspective of garnering a larger share of the import pie of that product category.

From the analysis above, there are 11 products — 100590, 300490, 020230, 851712, 260112, 390110, 848180, 401120, 870899, 100630 and 854470 — that have export potential for the Egyptian market. Some of these product categories, as said before, have exhibited negative imports' CAGR for the period under consideration, or, have a preferential tariff regime where imports from India lose out; however, India is either already a strong exporter of these categories to Egypt, or, has the potential given its global exports. It is for Indian industry to explore these options and focus on specific export projects to derive and cultivate a market.

4. National Tariff Lines

Each product category contains several sub-categories that are defined at the national tariff line (NTL), which can start at the 8-digit level and go on to 12 digits. The table below lists the NTLs, where available, for Egypt's top imports. This listing is included to provide greater insight into the micro-composition of Egypt's imports and to enable customizations at the factory level.

5. Trade Barriers

Egypt imposes non-tariff measures such as anti-dumping (AD), safeguards (SG), technical barriers to trade (TBT), and sanitary and phytosanitary (SPS) measures on trade, in addition to licensing, Customs facilitation and price controls. Select imports to Egypt that are subject to sanitary and phytosanitary barriers include milk and processed milk products, tea, wheat, potato seeds, live animals and their meat, animal-derived products, such as meat and meat products, beef, etc. In addition, select product imports subject to safeguards include semi-finished products of iron or non-alloy steel and steel rebar (bars, rods and coils) for construction



purposes, whereas those subject to anti-dumping measures include bars and rods of iron alloy or non-alloy steel rebar, coated electrodes of base metal for electric arc-welding (welding wires), blankets (other than electric blankets), etc.

A total of 134 barriers to trade are imposed by Egypt; these are all either in-force or initiated and are shown in a consolidated manner in the table below.

The specific trade barrier relevant for India is the anti-dumping measure imposed on the import of ball point pens (HS Code 960810). Further, it may be noted from the table above that there are non-tariff measures imposed by Egypt on imports of certain products that figure in the list of the top 25 products as identified in Section 2 of this report. These include HS Code 100590 (maize, excluding seed for sowing), HS Code 100630 (semi-milled or wholly milled rice, whether or not polished or glazed), HS Code 071350 (dried, shelled broad beans "Vicia faba var. major" and horse beans "Vicia faba var. equina and Vicia faba var. minor", whether or not skinned or split and HS Code 020230 (frozen, boneless meat of bovine animals).



6. Concluding Analysis

An analysis of the top 25 product imports by Egypt clearly reveals that its import basket is dominated primarily by food and agro products, electronics, energy, pharmaceuticals, plastics, iron, copper, fabrics, and machinery and equipment. Given the history of limited openness of the Egyptian economy, the magnitude of imports by Egypt in value terms is much lower when compared with other countries profiled so far.

The trends analysis of Egypt's top 25 imports indicates low imports' or negative imports' CAGR over the period 2014 to 2018 for several product categories, indicating a lethargy in its economy that has been struggling to achieve the GDP growth rates clocked during 2006–08. For instance, chemicals such as HS Code 390410 (poly 'vinyl chloride', in primary forms, not mixed with any other substances) and HS Code 851762 (machines for the reception, conversion and transmission or regeneration of voice, images or other data, incl. switching and routing apparatus, excluding telephone sets, telephones for cellular networks or for other wireless networks) have shown negative imports' CAGR, rendering exports of these products unattractive.

Egypt's direction of trade is skewed in factor of Arab-Mediterranean countries, EU countries, EFTA countries, Turkey, African countries such as Uganda, Eritrea and Ethiopia under COMESA, and MERCOSUR countries. Egypt is very proactive in imposing tariffs with several products having substantial tariff rates (for instance, levy of an average MFN tariff of 90% on one product category); however, these rates are drastically reduced for some of its FTA partners with preferential tariffs for products imported from the EU, Turkey, EFTA countries and COMESA countries. Amongst the top 25 import product categories, there are 13 product categories on which an average MFN tariff is levied; as India does not have an FTA with Egypt, it loses out to EU and African countries in these product categories.

The top 25 imports analysis for Egypt shows significant growth in imports of motor vehicles, fabrics, coal and iron ore, and some categories in the electronics sector. Of the products that have high potential for India are HS Code 851712 (telephones for cellular networks 'mobile telephones' or for other wireless networks) and HS Code 100630 (semi-milled or wholly milled rice, whether or not polished or glazed). HS Code 854470 (optical fibre cables made up of individually sheathed fibres, whether or not containing electric conductors or fitted with connectors) exhibits very high imports CAGR of 26% with no preferential tariffs; with India ranked at no. 3 as source country for Egypt, this product category appears to offer significant potential for Indian companies.

There exist certain product categories whose imports have witnessed a healthy CAGR, but India's ranking as an exporter to Egypt for such products is quite low in spite of a high global ranking. One such product category is HS Code 260112 (agglomerated iron ores and concentrates, excluding roasted iron pyrites) whose imports have grown at a robust rate of 16%, during 2014–18, but India is ranked nowhere. However, India is ranked high globally as the seventh-largest exporter of this product category; hence, there is export potential for this product that needs to be explored by Indian industry. The product category with HS Code

300490 (medicaments consisting of mixed or unmixed products for therapeutic or prophylactic purposes, put up in measured doses 'incl. those in the form of transdermal administration' or in forms or packings for retail sale, excluding medicaments containing antibiotics, medicaments containing hormones or steroids used as hormones, but not containing antibiotics, medicaments containing alkaloids or derivatives thereof but not containing hormones or antibiotics and medicaments containing provitamins, vitamins or derivatives thereof used as vitamins) has witnessed steady imports' CAGR of 4%. However, despite India being a strong global player in pharmaceuticals, it is ranked low at 22 for Egypt. The underlying reason for this is preferential tariff regime with EU and African countries with no preferential tariff for India thereby leading to losing out to these countries. Hence, there is scope for increased exports to Egypt from India if a preferential tariff can be agreed upon between Egypt and India.

Among top imports that have exhibited a low or even a negative imports' CAGR, but which yet offer potential is HS Code 870899 (parts and accessories, for tractors, motor vehicles for the transport of ten or more persons, motor cars and other motor vehicles principally designed for the transport of persons, motor vehicles for the transport of goods and special purpose motor vehicles, n.e.s.) — although it has registered negative imports CAGR of -11% and has an average MFN tariff of 9.1%, India is ranked no. 3 thus showing the capacity and ability of Indian firms in this sector. Hence, Indian companies could look at garnering a larger share especially given the disruptions in global supply chains.

Similarly, for the product category with HS Code 401120 (new pneumatic tyres, of rubber, of a kind used for buses and lorries, excluding tyres with lug, corner or similar treads), despite a negative imports CAGR of -4% and a preferential tariff for free-trade partners, India is still at ranked at no. 5. Hence, while there may not be import demand, but still Indian companies can look at garnering a larger share of this product's import pie.

Other examples include the product categories with HS codes 390110 (polyethylene with a specific gravity of < 0,94, in primary forms) and HS Code 848180 (appliances for pipes, boiler shells, tanks, vats or the like, excluding pressure-reducing valves, valves for the control of pneumatic power transmission, check 'non-return' valves and safety or relief valves) which despite exhibiting lower import CAGRs of 3% and 6%, respectively, present potential for exports by Indian companies. For HS code 390110, India has a high ranking of 11 for Egypt and 13 globally. Additionally, this is one of the few product categories that does not have a preferential tariff regime. Therefore, Indian industry could explore projects to increase its share of this product's imports by Egypt. For HS Code 848180 also, in spite of no preferential tariff and average MFN tariff is 18.6% applicable on Indian imports, India is ranked at 11 for Egypt and 14 globally; therefore, there seems to be innate ability for Indian companies to ramp up exports.

Despite exhibiting a negative imports CAGR of 1%, the product category with HS Code 100590 (maize, excluding seed for sowing) was the top-ranking import item in 2018 as the supply-demand gap for this product category (maize) in Egypt is 45%. From this, it follows that imports will, therefore, continue to remain important for this product. Although, globally India is the sixth-largest producer of corn, it is not a source country for Egypt. Therefore, the reason for no



exports of this product to Egypt should be explored. HS Code 020230 (frozen, boneless meat of bovine animals) has exhibited de-growth with a negative imports' CAGR of 1% for 2014–18. India ranks no. 2 as a source country for Egypt for this HS Code with a high global raking of no. 3; hence, there is considerable scope for industry players in this segment to gain a larger share of Egypt's imports of this product category.

While this report analyses the import profile in detail, it would be prudent to undertake a deepdive into each potential product for export by studying the historical and current market trends; policies and regulations; market share of companies; price trends; infrastructure; logistics; market drivers of sectoral/product growth; assessment of the growth potential of specific product(s)/services; identification of external business environment challenges; and, an analysis of sectoral developments, evolving policy and regulatory landscape, changing consumer preferences, technology trends, etc., to assess the viability of exporting products that appear to have a steady export demand and market.
